The Embassy of India, Monrovia invites sealed tenders/quotations from reputed Internet Service Providers (ISP) for providing internet connectivity with two separate lines of 10 mbps bandwidth each at Chancery Building of the Embassy situated at No.16 & 18, Coconut Plantation, UN Drive, Monrovia.

3. The bidding companies/firms should have the following requirements:
  - (i) The Company should have valid permit/registration from a competent local authority for providing internet services in Liberia.
  - (ii) The Company should have experience in providing internet services for a minimum period of 5 years and should be having a strong network coverage in Liberia.
  - (iii) The Company should be providing internet connectivity to the Diplomatic Missions/UN organizations and other well-known and reputed business entities in Liberia.
4. The quotation/bid along with duly filled-in Annexure-I and supporting documentary evidence should be submitted in a sealed envelope superscripted **“Tender for providing internet connectivity at Chancery Building, Embassy of India, Monrovia”** addressed to the **Head of Chancery, Embassy of India, No.16 & 18, Coconut Plantation, UN Drive, Monrovia** and must reach before 28.04.2025 by 1700 hrs. It should also be superscripted at the bottom left corner with the full name, postal address, email and telephone number of the firm/dealer. Bids may be hand delivered or sent by post at the aforementioned address so as to reach on or before the stipulated date and time. The Mission will not be responsible for any postal delay.

The bidder is required to deposit an Earnest Money Deposit (EMD) of US\$ 800/- in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form. The EMD should remain valid for a period of forty-five days beyond the final bid validity period. Bid securities of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract.
7. Quotation/bid and copies of the credentials/documents are required to be signed/self-attested by the applicant with official seal.
8. The bidder must fulfill the eligibility criteria as per the format specified at 'Annexure-I' and submit along with its financial quotation as per our requirement and terms and conditions in Annexure-II. Financial bids of only technically qualified companies shall be evaluated.
9. The quotations/bids would be rejected due to incorporation of any false information and furnishing fake or truncated documents.
10. The validity of the quotation shall be at least 30 days from the last date of submission of bid.
11. Bid received after the closing date and time as prescribed in the tender notice, shall NOT be accepted under any circumstances.
12. The Embassy of India reserves the right to reject any or all the bids without giving any notice or assigning any reason and the decision of the Mission in this regard shall be final and binding.

**TENDER DOCUMENT**

**Section 1: Scope of Work**

1. Sealed quotations are hereby invited by the Embassy of India in Monrovia from well reputed registered Internet Service Providers (ISP) to provide **two (02)** Dedicated Unshared wired 1:1 Internet Leased Line with **10 mbps bandwidth each** at the Chancery Building of the Embassy of India, situated at No.16 & 18, Coconut Plantation, UN Drive, Monrovia.
2. All bidders for this tender are advised to understand the Chancery building's layout carefully before submitting the tender.
3. The ISP shall use the existing arrangement of routers/switch boards and cabling installed in the Chancery building while providing the internet connectivity.
4. The ISP shall be responsible for any statutory requirement for installation and working of all the required equipment. Permission from various authorities may be the sole responsibility of the bidder.
5. The ISP shall have to guarantee continuous uninterrupted internet line availability along with all the equipment supplied by them.
6. Technical Specifications :-

- i. Two Dedicated P2P Internet Connection using Fiber Optic cable : The bandwidth for each link : 10Mbps Downlink / 10Mbps Uplink.
- ii. Internal LAN – Total of 12 Networks required.

**Section 2: Terms and Conditions**

1. Subject to the acceptance of the tender and any counter offer by the Embassy of India, the successful tenderer shall enter into a contract with the Embassy of India, that will comprise statement of conditions, rates and payment terms, specification of the internet services to be provided etc.
2. The initial Contract shall be valid for a period of One year (01 year). No escalation of

service charges during the period of contract. The contract may be extended annually on year to year basis as per the contract signed, on same terms and conditions and same rates, subject to satisfactory services provided by the provider. Either party can terminate the Contract by giving another party a month written notice.

3. Bidder must submit the following together with the tender documents:

- i Suitable documentation to show the company's experience (minimum 5 years) in providing internet services to reputed organizations (such as company brochure, appointment list & reference letter etc.)
- ii Broad financial and other details of the company including organization chart to show the company's management system and back up support for internet services provided in the Building.
- iii Quality certification (ISO 9001).

4. The bidder shall ensure an uptime of 99.5% for the entire duration. ISP will ensure maintaining services from the service centre which should be well equipped with service engineers and sufficient spares and should be able to resolve the issues which may arise at the soonest possible.

5. The Mission has estimated a cost of US\$ 22,000/- per annum towards provision of the **two (02) Dedicated Unshared wired 1:1 Internet Leased Line with 10 mbps bandwidth each** at the Chancery premises. The bidder is required to deposit an Earnest Money Deposit (EMD) of US\$ 800/- in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any of the Commercial Banks or payment online in an acceptable form. The EMD should remain valid for a period of forty-five days beyond the final bid validity period. Bid securities of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract.

6. **Penalty for Downtime:**

(i) If the services remain down for any reason for more than 4 hours on any business day including Saturday and Sunday, then 0.5% of the proportionate contract value will be deducted as penalty and if services remain down from 24 hours to one week including Saturdays, Sundays, and holidays then 1% of the proportionate contract value will be deducted as penalty.

(ii) However, if the services remain down for more than a week then 2% of the proportionate contract value will be deducted as penalty for each such weeks up to two weeks after which the Embassy will have right to terminate the contract and go for any other ISP.

7. **Performance Security:** To ensure due performance of the contract, the successful bidder shall be required to furnish Performance Security of 3% of the value of contract after award of the contract. Performance Security may be furnished in the form of an Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial bank, Bank Guarantee from a Commercial bank or online payment in an acceptable form. Performance Security should remain valid for a

period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. EMD will be refunded to the successful bidder on receipt of Performance Security. The Performance Security furnished in the form of an Account Payee Demand Draft, Fixed Deposit Receipt from a Commercial bank, Bank Guarantee from a Commercial bank or online payment, shall be returned interest-free post expiry of its validity. The proforma for Performance Security is as per Appendix-I of the tender document.

8. The bidder shall furnish Internet Bandwidth Utilization/performance reports on regular basis.

9. The ISP shall be paid on a monthly basis for the services rendered in the preceding month. The payment will be made either through Bank Transfer or Account Payee Cheque after supply of the items/goods and receipt of the invoice in this regard.

10. If a firm quotes NIL charges/consideration, the bid shall be treated as unresponsive and will not be considered.

11. The contract shall be awarded to technically qualified lowest bidder.

12. The contractor will be bound by non-disclosure agreement for confidentiality and secrecy as per Appendix-II of the tender document.
